DAY CAMP CHALLENGE GRANTS:

Donate At Your Camp (DAY Camp I)
Donate At Your Camp 2 (DAY Camp 2)

JCamp 180 is proud to introduce challenge grant programs directed to support affiliated day camps. The programs are designed to inspire and fund new ideas that will grow and sustain affiliated day camps. These grants mirror our highly successful challenge grant programs for overnight camps that have helped raise more than \$70 million. These programs are intended to inspire and fund new ideas to grow and sustain affiliated day camps.

Program Description

An amount of \$35,000 will be set aside for each eligible camp. Gifts of \$2,500 or more received in support of a day camp and that meet all other grant requirements will be matched by the Harold Grinspoon Foundation at a 1:3 ratio. A maximum match of \$11,667 per gift has been set. See illustration below.

All decisions regarding matching funds are made at the sole discretion of the Harold Grinspoon Foundation. Terms and conditions are subject to change and/or program may be terminated at any time.

GUIDELINES

- Eligibility for DAY Camp I is open only to those camps that have been approved for participation in **JCamp I80** and have an assigned mentor (See list on front).
- Working with your mentor, each day camp's director and/or camp committee must create a detailed plan for use of all funds raised by the program. This plan must be submitted by May 31, 2013.
- For a gift to be eligible for matching funds, a donor must make a minimum gift of at least \$2,500 in a single pledge to a camp. A donor may be an individual, family, corporation or foundation that has not made a pledge or gift designated for day camp.
- Members of the same family may give a "combined" single gift of \$2,500 or more. "Family" is limited to spouse, parents, grandparents, siblings, and children. Family trusts, foundations, and corporations may also qualify as donors. Gifts from a Jewish Federation or the JCC Association are not eligible.
- The use of donor gifts and HGF matching funds must be designated for projects/programs that meet the following criteria:
 - I. Gifts must exclusively or predominantly benefit the day camp/campers and add value to the organization. The match program is specifically intended to improve day camps and the day camp experience rather than the JCCs housing/sponsoring the day camps.
 - 2. Use of the gift must have sustained, long-term impact to improve the day camp/camp experience. Facility improvement should be a priority for funds raised.
 - 3. Up to 50% of total gifts raised may be used for new programming or to upgrade a part-time camp director position to full time.
 - 4. The camp's HGF mentor must approve the proposed use of funds submitted for HGF match.
- Camp must submit a DAY Camp I application for every pledge to be included in the campaign, by the pledge deadline of December 31, 2013.
- The first payment of at least one-third of the pledge amount must be made within 60 days of the application date, or the pledge will become ineligible for matching funds.
- Matching funds will be distributed on a quarterly basis (starting April 2013) based on the paid portion of pledge. Verification of payments is required by HGF (must include copy of check or credit card receipt).
- All pledges must be paid in their entirety by December 31, 2015.
