



Donate At Your Camp 4

JCamp 180, a program of the Harold Grinspoon Foundation, proudly announces Donate At Your Camp 4, a challenge grant program for selected camps. This program, which runs July 1, 2018 through June 30, 2021, is intended to boost the efforts of selected affiliated camps to raise funds to improve facilities, staff commitment and new programming, thereby enhancing the camp's ability to attract and retain campers. Donate At Your Camp 4 follows other JCamp180 challenges, which have contributed over \$15 million to participating camps.



About the program

The amount of \$35,000 will be set aside for each eligible camp as match to the camp raising \$105,000. Gifts of \$2,500 or more that are made in support of capital improvements, staff development, new programming or camper enrollment and meet all other grant requirements will be matched by the Harold Grinspoon Foundation at a 1:3 ratio to a maximum match of \$11,667 per gift. To earn the full \$35,000 in available matching funds, camps must receive no fewer than three gifts of \$35,000 or larger, or up to 42 gifts of \$2,500. See chart below for illustration.

GUIDELINES

- Eligibility for Donate at Your Camp 4 is open only to those camps that have been approved for participation in this JCamp 180 program and have an assigned mentor (See list below).
- For a gift to be eligible for matching funds, a **new donor** must make a minimum gift of at least \$2,500 in a single pledge to a camp. A **new donor** is an individual, family, corporation, or foundation that has not made a calendar year pledge or gift of \$800 or more since December 31, 2015.
- To be eligible for matching funds, a **previous donor** of \$800 or more in a calendar year (made after December 31, 2015) must increase the size of their largest previous gift. The sum of their gifts over the period 7/1/18 through 6/31/20 that exceed three times the largest previous annual gift is eligible to be matched as long as that increase is a minimum of \$2,500. A previous donor may be an individual, family, corporation, or foundation.
- Members of the same family may give a “combined” single gift of \$2,500 or more. “Family” is limited to spouse, parents, siblings, and children. Family trusts, foundations, and corporations may also qualify as donors. Gifts from a Jewish Federation or the Foundation for Jewish Camp are not eligible.
- Gifts must be cash or cash equivalent to qualify. In kind contributions, discounts on services or goods, art, real estate, or other non-cash instruments will not be matched by JCamp180 funds. Stocks, bonds, and other cash equivalents will be matched. Please check with the JCamp180 grants administration team to verify eligibility of non-cash gifts.

GUIDELINES (CONTINUED)

- For camps that are a program of a parent organization, gifts must predominantly benefit the camp operations. The match program is specifically intended to improve the camp experience rather than other programs of the umbrella organization. To assure that our foundation funds focus on camp programs, camps must submit to their JCamp I80 mentor a plan for the use of JCamp I80 matching funds for approval.
- Donor gifts and matching funds must be used for **capital improvements, staff development, camper recruitment and retention, or new programming**. Examples of such use are:
 1. Supplement salaries to convert part time camper-facing staff to full time staff
 2. Introducing new programming to attract campers
 3. Implement improved staff training methodology
 4. Purchase major pieces of program support equipment
 5. Infrastructure construction or capital maintenance
- In order to participate in Donate at Your Camp 4, each camp must submit an application through our on-line grants management system. Each gift (or pledge) must also be documented by submitting proof of payment through our grant management system by the pledge deadline of **June 30, 2019**. Pledges for gifts to be paid over time must be received by the camp within the period of July 1, 2018 through June 30, 2019 and must be paid in full prior to June 30, 2021.
- Matching funds will be distributed on a quarterly basis (starting September 2018) whenever the paid portion of a pledge exceeds the \$2,500 minimum gift level. Proof of payment, such as a copy of the check or credit card receipt must be submitted through the on-line grant management system. Matching grant funds will be distributed only for the portion of pledges paid by **June 30, 2021**.
- This matching grant program will be managed through the Harold Grinspoon Foundation's on-line grant management system. Eligible camps are required to have a representative participate in the program training webinar. Address questions to grants@HGF.org.
- All decisions for matching funds are at the sole discretion of JCamp I80 and the Harold Grinspoon Foundation. Terms and conditions are subject to change and/or termination at any time.
