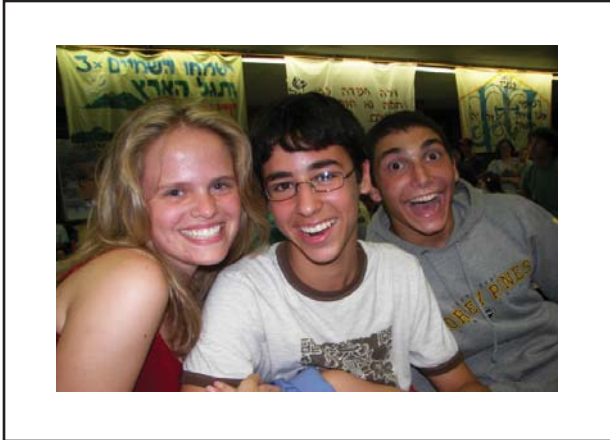


# MEET YOUR MATCH 4

The Grinspoon Institute for Jewish Philanthropy, a program of the Harold Grinspoon Foundation, proudly announces *Meet Your Match 4*, a challenge grant program from **July 1, 2009 through January 29, 2010**. The program is intended to boost the efforts of affiliated camps to raise funds to improve their facilities and thereby enhance the Jewish camping experience. *Meet Your Match 4* follows other Grinspoon Institute challenges, which, since 2006, have helped Institute camps raise over \$40 million.

## Program Description

A sum of \$75,000 will be set aside for each eligible camp. Gifts of \$10,000 or more that are made in support of capital improvements only and meet all other grant requirements will be matched by the Harold Grinspoon Foundation at a 1:3 ratio. See chart below for illustration.

#### Guidelines for *Meet Your Match 4*

- To be eligible for matching funds from the Harold Grinspoon Foundation, a gift must meet all of the following requirements:
  - **New donor:** The donor must make a minimum gift of at least \$10,000 in a single pledge to a camp on or after July 1, 2009. A **new donor** is an individual, family, corporation or foundation that has not made a pledge or gift of \$10,000 or more since July 1, 2006.
  - **Previous donor:** A donor who has made a gift of \$10,000 or more for any purpose after July 1, 2006 must triple the previous gift. This gift must be made on or after July 1, 2009. A **previous donor** may be an individual, family, corporation or foundation.
- Members of the same family may make a combined single gift of \$10,000 or more. “Family” is limited to spouse, parents, siblings and children. Family trusts, corporations and foundations may also qualify as donors. Gifts from a Jewish Federation or the Foundation for Jewish Camp are excluded.
- Donor gifts and matching funds must be used for **capital improvements only**, defined as the following:
  1. Construction of buildings or portions of buildings
  2. Major repairs to buildings or portions, but not maintenance
  3. Improvements to grounds, but not normal upkeep
  4. Major pieces of equipment
  5. Infrastructure construction or maintenance of septic systems and water systems
- Upon receiving a donor’s pledge, the camp must submit a *Meet Your Match 4* application documenting the donor’s eligibility and providing required information. The Harold Grinspoon Foundation then reserves funds to be distributed as a 1:3 match when proof of payment (copy of check) is furnished.
- A donor’s first payment amounting to at least one-third of the pledge must be received within 60 days of the camp’s *Meet Your Match 4* application, and the pledge must be paid in full by January 31, 2012.
- The Harold Grinspoon Foundation will disburse matching funds on a quarterly basis, starting in October 2009, based on the paid portion of the pledge.
- If the donor who makes a pledge does not pay the committed amount, the pledge lapses and is ineligible for matching funds. The pledge cannot be transferred to another donor.
