Meet Your Match 8

JCamp 180, a program of the Harold Grinspoon Foundation, proudly announces Meet Your Match 8, a challenge grant program from October 1, 2018 through September 30, 2021. The program is intended to boost the efforts of selected affiliated camps to raise funds to improve their facilities and thereby enhance the lewish camping experience. Meet Your Match 8 follows other JCamp 180 challenges, which, since 2004, have helped Institute camps raise over \$85 million.



About the program

A sum of \$75,000 will be set aside for each eligible camp. Gifts of \$10,000 or more that are made in support of capital improvements only and meet all other grant requirements will be matched by the Harold Grinspoon Foundation at a 1:3 ratio to a maximum match of \$25,000 per gift. See chart below for illustration.

GUIDELINES

Eligibility for Meet Your Match 8 is open only to those camps that have been approved for participation in Camp 180 and have an assigned mentor (See list below).

- · For a gift to be eligible for matching funds, a new donor must make a minimum gift of at least \$10,000 in a single pledge to a camp. A new donor is an individual, family, corporation, or foundation that has not made a calendar year pledge or gift of \$3,333 or more since December 31, 2015.
- To be eligible for matching funds, a previous donor of \$3,333 or more in a calendar year (made after December 31, 2015) must increase the size of their largest previous gift. The sum of their gifts over the three-year period 10/1/19 through 8/31/21 that exceeds three times the largest previous annual gift is eligible to be matched as long as that difference is a minimum of \$10,000. A previous donor may be an individual, family, corporation, or foundation.
- Members of the same family may give a "combined" single gift of \$10,000 or more. "Family" is limited to spouse, parents, siblings, and children. Family trusts, foundations, and corporations may also qualify as donors. Gifts from a Jewish Federation or the Foundation for Jewish Camp are not eligible.
- Gifts must be cash or cash equivalent to qualify. In kind contributions, discounts on services or goods, art, real estate, or other non-cash instruments will not be matched by Camp 180 funds. Stocks, bonds, and other cash equivalents will be matched. Please check with the JCamp 180 grants administration team to verify eligibility of non-cash gifts.

GUIDELINES (CONTINUED)

- Donor gifts and matching funds must be used for capital improvements, defined as the following:
 - 1. Construction of buildings or portions of buildings
 - 2. Major repairs to buildings or portions of buildings, but not maintenance
 - 3. Improvements to grounds, but not normal upkeep
 - 4. Major pieces of equipment
 - 5. Infrastructure construction or maintenance of septic and water systems
- In order to be considered for match by the Foundation, each camp must submit a MYM 8 application through our on-line grants management system. Each gift (or pledge) must be documented by submitting proof of payment through our grant management system by the pledge deadline. Pledges must be received by the camp within the period of October 1, 2018 through September 30, 2019 and must be paid before September 30, 2021.
- Matching funds will be distributed on a quarterly basis (starting April 2019) whenever the paid portion of a pledge exceeds the \$10,000 minimum gift level. Proof of payment, such as a copy of the check or credit card receipt must be submitted through the on-line grant management system. Matching grant funds will be distributed only for the portion of pledges paid by August 31, 2021.
- This matching grant program will be managed through the Harold Grinspoon Foundation's on-line grant management system. Eligible camps are required to have a representative participate in the program training webinar.
- All decisions for matching funds are at the sole discretion of JCamp 180 and the Harold Grinspoon Foundation. Terms and conditions are subject to change and/or termination at any time.
